**Further Reforms to NSW  
Business Migration Program**

A number of reforms to the NSW business migration program were announced from 1 September 2011:

- prospective business migrants no longer need to conduct their business research visit on a Business (Short Stay) 456 visa
- the introduction of new Business Commitment and Investment Commitment templates
- applicants for NSW sponsorship for provisional visas including the Investor 165 and Business Talent 132 visa must attend an interview with NSW.

The NSW Government has now announced further reforms to the NSW business migration program from 1 November 2011. These reforms include:

- introduction of separate thresholds for Sydney and regional NSW
- revised thresholds for the Business Talent visa
- revised arrangements for applicants who wish to change their proposed business activity

- relaxation of the requirement for an applicant's Business Commitment to be consistent with their business skills and experience
- the exclusion of a limited number of industry sectors from business migration to Sydney. Applicants in these sectors can still migrate to regional NSW.

These reforms should not adversely affect applicants who have already been sponsored by NSW.

The reforms will affect new applicants seeking NSW sponsorship for provisional visas from 1 November 2011.

## **Update to NSW State Migration Plan**

The NSW State Migration Plan was updated from 23 September 2011. The Plan now includes almost 150 occupations.

There are seven new occupations now open for sponsorship for the Skilled Sponsored 176/886 visa. They are:

- Chief Information Officer
- Systems Administrator
- University Lecturer
- Construction Project Manager
- Painting Trades Worker
- Early Childhood (Pre Primary School) Teacher
- Financial Investment Adviser

There are two new occupations now open for sponsorship for the Skilled Regional Sponsored 475/487 visa:

- Electrician (Special Class)
- Metallurgist

## **Skilled Migration**

NSW and most other States/Territories have seen a considerable decline in applications for State/Territory sponsorship for skilled migration since 1 July 2011. This coincides with the introduction of the new points test for general skilled migration.

While it is still too early to draw any conclusions feedback from
